The position will be based in Jakarta, the capital of Indonesia, where basic living needs, including accommodation, banking facilities, medical facilities and telecommunications/internet services are readily available. All staple foods can be found in the markets, e.g.: rice, meat, vegetables, fruit, cooking oil, salt, etc. Many imported goods are available in Jakarta and other places throughout Indonesia. Jakarta has many good restaurants with good health standards and most guesthouses provide food. In Indonesia the most used means of transportation are taxi or local bus. Mobile phone is the most dependable tool to be in-touch with colleagues and friends. Internet service is readily available and affordable at most apartment complexes. ATMs are everywhere in Indonesia and Western cards can usually be used to withdraw Indonesian Rupiah.

As this is a national UN Volunteer assignment, the UN Volunteer will be responsible for arranging his/her own housing and other living essentials. National UN Volunteers are part of the insurance plan.

Maternal and Adolescent Nutrition Officer

Organizational Context & Project Description

UNICEF Indonesia Country Office consists of six programme clusters (Nutrition, Health, WASH, Education, Child Protection, Social Policy) as well as other clusters (Programme Monitoring and Evaluation, Communications, Private Fundraising and Partnerships, Operations). The Nutrition section currently consists of two international and five national staff members in Jakarta as well as five national staff members in UNICEF Field Offices in Banda Aceh, Surabaya, Kupang, Makassar and Papua. The Nutrition section works on five programming areas, namely, i) Early childhood malnutrition, ii) Care for wasted children, iii) Maternal and adolescent nutrition, iv) Prevention of overweight, and v) Nutrition in Emergencies. The National UNV Specialist will primarily provide support to the third output, maternal and adolescent nutrition. The Nutrition section will provide supervisory oversight, coaching and mentoring as required for the UNV. Apart from the Nutrition section and other clusters within UNICEF, the UNV is expected to work very closely with the Family Health and Nutrition Directorate of the Ministry of Health, Ministry of Education, Ministry of Religious Affairs, Bappenas and other partners that have a stake at Maternal and Adolescent Nutrition programme.

Task description

Within the delegated authority and under the supervision of Chief of Nutrition or his/her designated mandated representative(s), the Maternal and Adolescent Nutrition Officer (National UN Volunteer) will:

- Provide knowledge management support for the maternal and adolescent nutrition programme area, such as conducting literature reviews, data analysis, policy analysis, report and manuscript writing, audio visual publications, social media posts and keeping stock of emerging global and local literature and other resources related to maternal and adolescent nutrition.
- Provide support in organizing and preparing meetings with government stakeholders and other partners for consultation and coordination purposes.
- Provide support in establishment of a multi-stakeholder, multi-sectoral maternal and adolescent nutrition prevention coordination platform by networking with external partners, gathering information on partners' interests and agendas, preparing meetings and coordinating with government and other partners as appropriate.
- Provide support for conducting events on maternal and adolescent nutrition programme area including networking with youth and adolescent network for capacity building and key messages dissemination
- Provide support in development of information and communication materials for high-level advocacy to promote evidence-based policy and programmatic actions for maternal and adolescent nutrition in the country as well as for public education and awareness generation purposes.
- Any other related tasks as may be required or assigned by the supervisor.

Furthermore, UN Volunteers are required to:- Strengthen their knowledge and understanding of the concept of volunteerism by reading relevant UNV and external publications and take active part in UNV activities (for instance in events that mark International Volunteer Day)- Be acquainted with and build on traditional and/or local forms of volunteerism in the host country- Provide annual and end of assignment reports on UN Volunteer actions, results and opportunities using UNV's Volunteer Reporting Application- Contribute articles/write-ups on field experiences and submit them for UNV publications/websites, newsletters, press releases, etc.- Assist with the UNV Buddy Programme for newly-arrived UN Volunteers- Promote or advise local groups in the use of online volunteering, or encourage relevant local individuals and organizations to use the UNV Online Volunteering service whenever technically possible.

The rapidly changing nature of novel coronavirus COVID-19 has placed significant and increasing restrictions on the freedom of movement of people, even within countries. Such restrictions may affect the ability national UN Volunteers to begin their assignments at their assigned duty station or limit the ability to enter UN premises. Thus, UNV cannot guarantee assignments will proceed as normal.

Candidates for national UN Volunteer assignments requiring travel to the duty station may be exceptionally granted during this period alternative working arrangements to work from their place of recruitment until restrictions are lifted. Candidates for national UN Volunteer assignments may also need to begin their assignments remotely in cases where access to UN premises is restricted. These are decisions at the discretion of the host entity. Candidates proceeding to interview are recommended to discuss travel requirements, any restrictions, and possible alternative arrangements with the host entity. If selected, candidates should carefully consider the circumstances before accepting UNV's offer.

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

Travel to duty station (if applicable) and a Settling-In-Grant will be provided in the event the duty station is not within commuting distance from the place of recruitment. The applicable Volunteer Living Allowance is provided monthly to cover housing, utilities and normal cost of living expenses. Life, health and permanent disability insurance are included (health insurance for up to 3 dependents), as well as final repatriation (if applicable) and resettlement allowance for satisfactory service.

Furthermore, in non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, a Well-Being Differential (WBD) on a monthly basis will be provided.

Supervision, induction and duty of care of UN Volunteers (Roles and Responsibilities of Host Entities)

UN Volunteers should be provided equal duty of care as extended to all host entity personnel. Host entity support to the UN Volunteer includes, but is not limited to:

- Introductory briefings about the organisation and office-related context including security, emergency procedures, good cultural practice and orientation to the local environment;

- Support with arrival administration and official processes;
- Structured guidance, mentoring and coaching by a supervisor including a clear workplan and performance appraisal;

- Access to office space, equipment, IT support and any other systems and tools required to complete the objectives of the assignment including a host entity email address;

- Access to shared host entity corporate knowledge, training and learning;

- Any necessary security measures, ensuring that UN Volunteers are covered by the United Nations Security Management System (UNSMS) in line with the UNDSS Security Policy Manual;
